

LIABILITY RELEASE for Living Water Surf School, LLC.

EXPRESS ASSUMPTION OF RISK

This is an important document. You must read this agreement, understand it and sign it to be allowed to participate in Living Water Surf School activities. By signing this agreement, you waive certain legal rights, including your right to sue.

I, the parent or guardian, affirm and acknowledge I understand the inherent hazards and risks associated with snorkeling, surfing, skateboarding, scindiving, skimboarding, participating in wave runner(jet ski) activities and all the ocean and shore activities conducted by Living Water Surf School. I understand the hazards and risks can lead to severe injury and even death.

Despite the potential hazards and dangers associated with snorkeling, surfing, skateboarding, scindiving, skimboarding, participating in wave runner(jet ski) activities and all the ocean and shore activities conducted by Living Water Surf School, I wish to proceed and freely accept and assume all risks, dangers, and hazards which may arise from these activities and which could result in personal injury, death, and property damage to my child or ward.

I am familiar with my child's physical condition and am aware of no condition or disability which would impair my child's ability to participate in snorkeling, surfing, skateboarding, scindiving, skimboarding, participating in wave runner(jet ski) activities and all the ocean and shore activities conducted by Living Water Surf School.

In consideration of being allowed to participate in Living Water Surf School as well as the use of any of the facilities and equipment of the below listed Releasees, I hereby agree as follows:

1. To waive and release any and all claims I may have in the future against any of the following named persons or entities (hereinafter referred to as Releasees): the City of Boca Raton; the City of Pompano Beach; Quiksilver; all instructors, including William Zimmerman; Living Water Surf School, its staff, volunteers and Board.
2. To release and hold harmless the Releasees, their officers, directors, employees, representatives, agents, and volunteers, from all liability and responsibility whatsoever, for any claim or cause of action (lawsuit) that I, my estate, heirs, executors or assigns may have for personal injury, property damage or wrongful death arising from snorkeling, surfing, skateboarding, scindiving, skimboarding, participating in all wave runner(jet ski) activities and all the other activities conducted by Living Water Surf School whether caused by the active or passive negligence of the Releasees or otherwise.
- 3 .Acknowledge that I am not relying on any oral or written representations or statements made by the Releasees other than what is set forth in this agreement.
4. This agreement shall be governed by and interpreted in accordance with the laws of the State of Florida.
